PUBLIC HEARING - PROPOSED LOCAL LAW A OF 2011 - ADMINISTRATIVE FEE

REIMBURSEMENT

With proof of notice having been duly published and posted, Supervisor Jones opened the Public Hearing at 7:06 P.M., asking for comments on the proposed local law providing for reimbursement of professional consultation fees.

Town Engineer Ackart suggested adding "fiscal, accounting services" to the consultants list contained in Section 1.A. in light of the anticipated sewage works corporation with the townhouse project.

In response to a question from George Sproule, it was explained the Town has the right to retain a consultant for fiscal services.

Doug Paddock asked if it includes reimbursement for employees of the Town. Attorney Bailey responded the intent is to include professional employees such as the Town Engineer, but not the Town Board or Highway, etc.

The different percentages for the escrow deposits listed in Section 2. were questioned. Attorney Bailey explained this wording came from a model local law and he would check into the reasons for the different percentages.

Doug Paddock asked if this was an "open check book" as there were no maximum fees and/or charges noted in the law. The escrow amount will depend on the project complexity.

Attorney Bailey explained he worked from several model laws to create what he believes to be a succinct clearer law. We will roughly know what the escrow amount will be in advance.

The fees are collected by the Town Clerk.

George Sproule asked when is the need and how much determined. Councilperson Folts stated the Town can hire and charge the developer if the Town Attorney can't do it. It was clarified this would include both the Town Attorney and Town Engineer.

Supervisor Jones stated he feels the tax payers should not be paying for professional services that benefit a developer, which is why he brought this law forward. Mr. Sproule stated this will deter development which actually benefits the tax payers by adding to the tax base

A lengthy discussion ensued regarding Section 2. Escrow Accounts. It seems unfair to charge a fee to review things if staff is already on the payroll as a professional. If the employee is salaried, they would not get paid any more money for the additional time they are working. If the staff is already on board with the

needed capabilities, it should be a Town service. If the additional hours required on a project infringe on staff's ability to do their work, the Town should be paid for the additional hours. If a project is too big or we do not have the expertise and need to hire another professional to do the work, the Town should be reimbursed.

The recently enacted subdivision law includes reimbursement for professional fees.

The public hearing was left open.

Town Officials:

Town Engineer:

- Minutes of the January 10, 2011 Water/Sewer Committee meeting are on file.
- East Bluff Drive residents have petitioned the Town to extend water and sewer services.
- Three firms are being considered to provide engineering, planning, and environmental consultation and advice to the Town on an as needed/authorized annual basis. Proposals are due January 28th.
- The Finger Lakes Museum Facilities Committee spent the last two days interviewing design teams for the project.
- Attorney Bailey will incorporate Keuka College in the rate schedule.

COUNCIL

- The Branchport Hamlet Master Plan Steering Committee for the \$32,000 Community Planning Grant held a Discovery/Vision Session on January 12th. The objective of the session was to identify specific issues, opportunities and assets for the Hamlet area. A recommendation to engage the services of Matt Ingalls Planning & Design will be coming forward to the Town Board.
- Yates County's allocation for workers' compensation to the Towns is under review. Councilperson Simmons stated the Town is requesting a quote for worker's compensation coverage from our insurance carrier, L.D. Sprague Insurance.
- Yates County is also reviewing options for the allocation of elections costs. The Election Commissioners are putting information together for presentation to all Town Boards.
- The Zoning Board considered one variance application at their January $13^{\rm th}$ meeting.
- The Planning Board accepted the proposed site plan for a new dock at 495 Mill Street.

It was noted the Town needs to actively address hydrofracking regulations if a moratorium is passed. Peter Gamba is Jerusalem's representative to the Yates County Marcellus Shale Task Force.

Based on information gathered, an appointed assessor is desirable due to present regulations and required schooling. Our assessor has historically been involved in numerous projects such as roads, windmills, etc.
