QUESTIONS AND ANSWERS:

Further questions related to grant funding, experience with sewage works corporations, the newly enacted Phase II storm water regulations, the Harborview townhouse project and the Finger Lakes Cultural Museum were posed following their presentation.

DISCUSSION:

Councilor Simmons thought Larson's presentation was strong because they addressed funding in their proposal and their involvement with the gas drilling companies would be helpful as we draft regulations.

Councilor Stewart questioned only 27% of Larson's revenues coming from municipalities and who the bigger client would be. He would recommend Clark Patterson Lee. Their extensive water system experience would be beneficial in addressing our THM problem.

Supervisor Jones feels the Town has a good relationship with Clark Patterson Lee. They offered to attend the hydrofracking meetings and are aware of the effects of drilling. He is concerned with Larson having contracts with 19 gas drilling companies.

Councilor Parson supports Larson because they are an employee-owned company. Larson is located in Corning; the middle of the drilling area and they have more to bring because they are involved in gas drilling. Larson sees both sides of the gas drilling issue.

Selection of an engineering firm will be placed on the March 16th Town Board agenda. References need to be checked.

SUPERVISOR'S LETTER - KEUKA PARK SEWER DISTRICT:

Supervisor Jones proposed including a letter to the Village of Penn Yan along with our Sewer #2 payment. It was the consensus of the Board not to send the letter as drafted and to allow discussions with the Jerusalem Sewage Committee to continue.

With there being no further business, on a motion of Councilor Stewart, seconded by Councilor Parson, the meeting was adjourned at 4:54 P.M.
