HIGHWAY SUPERINTENDENT

- Written Budget Highway report on file in the Office of the Town Clerk.

PUBLIC COMMENT - FENCE REGULATIONS

Matt Piczak, 559 Assembly Avenue requested the Town Board enact legislation regulating fences following the erection of his neighbor's alleged "spite" fence. Pictures were displayed and information packets distributed to the Board. While the Town reduced Mr. Piczak's property assessment due to the fence, the ability to sell his property is also impacted. This has become a safety issue as materials such as barbed wire have been added to the fence, posing a danger to our community. Mr. Piczak appeared before the Planning Board in October 2011 when this matter was in litigation.

Councilors Folts and Killen will work with Planning Board Chairman Bob Evans drafting fence regulations.

Attorney Bailey will draft a moratorium on fences.
