Councilor Killen reported the following:

- The Town Clerk Committee met on January 31st to discuss improving efficiencies, communication and streamlining data.
- The Sunshine Committee met on January 18th and will be planning a summer picnic.
- The Personnel Committee is scheduled to meet February 28th.

Councilor Parson reported the Town Board received a comprehensive $4^{\rm th}$ quarter 2012 report from the Assessor. 206 agricultural exemptions have been recorded, along with five Cold War exemptions and several are pending.

Whereas; the purchase price for an individual piece of equipment cannot exceed \$4,999;

Whereas; in order to be eligible for the rebate, the purchase and delivery of the equipment must take place by March 12, 2013 and all documentation must be submitted no later than April 20, 2013;

Whereas; the Town of Jerusalem has a quote for a new Toshiba E-Studio 356 in the amount of \$4995.00; Whereas; the Toshiba E-Studio 356 is eligible for this grant;

Whereas; the service agreement for the Toshiba E-Studio 356 is \$57.00 per month;

NOW, THEREFORE BE IT RESOLVED, that the Town of Jerusalem hereby determines that the proposed engineering study to evaluate the feasibility of a Wastewater Collection and Treatment System is a Type II action in accordance with 6 NYCRR Section 617.5(c)(18) which constitutes the information collection including basic data collection and research, water quality and pollution studies, traffic counts, engineering studies, surveys, subsurface investigations and soils studies that do not commit the agency to

undertake, fund or approve any Type I or Unlisted action; and is therefore not subject to review under 6 NYCRR Part 617.

PUBLIC COMMENT:

Paul Butler stated concerns over the newly enacted 54A Scenic Overlay District. It was clarified for Mr. Butler that the overlay district is not a "no build" zone as he had interpreted the law.

Mike Sullivan was introduced. He recently joined the Finger Lakes Museum as their Education Director. He thanked the Board for announcing the Brrranchport Winter Fest, noting there are more events to be planned as the Museum is becoming more visible to the public prior to their physical doors opening.

OTHER BUSINESS:

Councilor Parson stated it is difficult to prepare for our meetings when information is not received in a timely manner. Items should not be discussed if they are not on the agenda. Supervisor Jones stated while he understands his position, the grant resolutions presented tonight were time sensitive so they needed to be acted on or a special meeting held.

Councilor Parson requested a staff meeting be scheduled to get the departments together. Councilor Killen stated this is being discussed by the Personnel Committee and they are scheduled to meet on February $28^{\rm th}$.
