WHEREAS, Gary E. and Janet E. Molyneaux have applied to the Town of Jerusalem for the establishment of an "Open Development Area"

within the meaning of Section 280-a of the Town Law so as to allow construction of structure on a lot within said area that does not directly abut a public highway, and

WHEREAS, Section 280-a of the Town Law authorizes the Town to establish an Open Development Area on such rules as the Town deems reasonably required to insure access by emergency vehicles to lots served by a private road, and

WHEREAS, the applicants have filed with the town a survey map prepared by Richard E. Kaczynski, Land Surveyor, dated June 15, 2013 (Job No. 00-813) showing provision for access to one proposed lot designated as 1.021 Acre by right-of-way fifty feet in width, and

WHEREAS, the Town of Jerusalem Planning Board has recommended approval of this application provided that the Town Code Enforcement Officer, Highway Superintendent, and the Branchport/Keuka Park Fire Chief sign off on the application and give their approval to ensure they are also satisfied with the construction of the private roadway, and

WHEREAS, The Town Board has found that this action will not have significant adverse environmental impact as defined in the New York State Environmental Quality Review act;

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Jerusalem, in regular session duly convened, as follows:

1. Open Development Area Number 2013-1 of the Town of Jerusalem be and the same hereby is established comprising one parcel having 1.021 acre of land as shown together with the Right of Way in Common, 50 feet wide, along the north line of said 1.021 acre lot on the aforesaid map on file with the town, subject to the following Requirements, which must be satisfied prior to the issuance of a certificate of occupancy for any structure on said parcel:

2. The provisions of the Rules for Private Roads, found in Town of Jerusalem Code Chapter 93, Article Two, shall apply.

3. The Code Enforcement Officer, the Town Highway Superintendent and the Branchport/Keuka Park Fire Chief shall sign off on the application and give their approval.

4. If and when buildings are to be constructed on any part of the approximately fourteen acre parcel now owned by the said Gary E. and Janet E. Molyneaux that will have access to East Bluff Drive by

easement and will not constitute a Subdivision, the owner shall apply to the Town Board for approval of an extension to this Open Development Area. Such approval shall not be granted and no building permit shall be issued for any such building until the requirements of Section 280-a of the New York State Town Law and the Town of Jerusalem Rules for Private Roads have been satisfied for such extension.

5. This resolution is limited to this particular application and is not to be precedent setting.

6. This resolution shall take effect immediately.

He also recommended they include the Code Enforcement Officer in their discussions.

Jonathan Hunt addressed the Board with regard to the permit fee for his high tunnel greenhouse structure to clarify if it qualifies for

the \$.05/square foot agricultural building permit fee. He provided and reviewed a packet of handouts supporting the agricultural building permit fee. A lengthy discussion on Mr. Hunt's structure and the materials he provided resulted in the determination that Resolution #148-12 needed to be amended for clarification as the intent of the resolution has resulted in these consequences.

LOCAL WATERFRONT REVITALIZATION PLAN CONTRACT REVIEW

Don Naetzker, Executive Director for the Finger Lakes Cultural Museum administers the Local Waterfront Revitalization Strategy grant. He met with Town Clerk McMichael to review the Grant Agreement with the New York State Department of State for submission to fulfill the Town's obligations under the Consolidated Funding Application #18725. The Subcommittee received one response to their RFP for consulting services. The subcommittee interviewed and recommends the Town engage the services of Ingalls Planning & Design to prepare the Town of Jerusalem Waterfront Revitalization Strategy. Ingalls included Trowbridge Wolf Michaels Landscape Architects on the team to ensure our needs are met and that this dovetails with the Keuka College campus master plan.
