Zoning Change Needed

Due to the rapidly increasing number of attractions in the Finger Lakes, and the declining number of visitors at the established wineries, it is very important for us to begin offering excellent lunches at the winery both as a way to attract a few more visitors, and also to enable visitors to consume a healthy meal before visiting more wineries.

Although nearly everyone on each of the town boards have told us they support the idea of Hunt Country Vineyards having a luncheon café, The Zoning Board cannot find a way to allow this as a Special Use. By changing the zoning law to allow farm wineries and farm breweries to have restaurants as a Special Permitted Use only, the Town Board can help the Zoning Board to allow this as a listed Special Use. Furthermore, the town, through the Zoning Board will still have the obligation and ability to decide on a case by case basis if such an application is appropriate and thus will have complete control of each decision.

After three months of conflicting advice from each of the town boards, we are asking you, the town board, to allow this zoning change to be adopted as soon as possible. We understand there is a committee already working on other changes to the zoning law. Can this request be added to the others?

What can you do to help this to happen? Who is on this committee? Can we address this committee? Can we get this law which was created before the farm winery law was passed in 1976 to be updated and to allow this use which was not envisioned then, but is greatly needed now?


