BRANCHPORT HAMLET SUBCOMMITTEE

Tim Cutler reported the Branchport Hamlet Subcommittee is looking to create a walking path along Sugar Creek. The Subcommittee is still waiting for feedback on the proposed façade guidelines.

AGR ZONING REVIEW SUBCOMMITTEE

KEUKA COLLEGE ATHLETIC FIELD

The Town Board continued discussion on a zoning amendment in the agricultural-residential (AGR) district to allow the College athletic complex. The Planning Board recommended it be added as a special permitted use and the Zoning Board recommended it be added as a permitted use. Jerry Hiller, Vice President of Finance and Administration and Dave Sweet, Athletic Director were present representing the College. Council requested legal opinion from Attorney Graff on what obligation the Town has given the protection afforded to education uses per the attached case law. Deputy Supervisor Stewart or Supervisor Killen will advise the College of Attorney Graff's opinion.

HUNT COUNTY WINERY CAFÉ:

Art Hunt, Hunt Country Winery submitted a letter and supporting documentation to the Town Board requesting a zoning amendment in the agricultural-residential (AGR) district to allow a café at their winery (attached). Planning Board Chair Cutler stated the Planning Board is drafting conditions for consideration by the Town Board to add café to AGR district as a special use. Several residents in attendance stated their support of Mr. Hunt's request to the Town Board.

AGR ZONING REVIEW SUBCOMMITTEE:

Clarification of the charge to the AGR Zoning Review Subcommittee was requested by Bob Morse and Mike Folts. They were original members, but stated the Subcommittee has not met in the past year. Town Clerk McMichael will provide copies of the original proposed local law that included lot size and lot coverage to Mr. Morse. It was explained the proposed amendments impacted boat storage, which was addressed by Councilor Jones working with Subcommittee Chair Jim Crevelling. AGR zoning amendments have now expanded to include the College athletic complex and Hunt Country Winery's request for a café. Deputy Supervisor Stewart will contact Subcommittee Chair Crevelling.
