### RESOLUTION CREATING AN OPEN DEVELOPMENT DISTRICT

On a motion of Supervisor Killen, seconded by Councilor Dinehart, the following was

ADOPTED Ayes 5 Anderson, Dinehart, Jones, Killen, Parson Nays 0

WHEREAS, the Angelo T. Licciardello Revocable Living Trust is the owner of a parcel of land situated at 8242 East Bluff Drive in the Town of Jerusalem, County of Yates and State of New York and identified as Tax Map #: 103.49-1-5 (hereinafter the "Parcel"); and

WHEREAS, the existing Site Plan for the Parcel shows access to this parcel being provided by a private road, approved by the Town Planning Board; and

WHEREAS, this private road has not yet been improved to the satisfaction of the Town Board to provide the necessary access required by New York State Town Law §280-a; and

WHEREAS, the Town Board is desirous of creating an Open Development Area over this Parcel, pursuant to Town Law §280-a 4. so that the Town Code Enforcement Officer can issue a building permit for the erection of a building that does not yet have access from a street or highway on an official map or as otherwise permitted by §280-a and from a street or highway that is not yet suitably improved; and

WHEREAS, the Town Planning Board has provided the Town Board its advice and has reported to the Town Board that it is in favor of the Town Board establishing an Open Development Area over the Parcel.

NOW, THEREFORE, BE IT RESOLVED that the Town Board of the Town of Jerusalem does hereby establish an Open Development Area, pursuant to Town Law §280-a 4. over the entire Parcel; and be it further

RESOLVED, that, pursuant to Town Law §280-a 4., permits may be issued for the erection of buildings on the Parcel to which access is given by the aforesaid private highway, subject to the condition that any building permit issued by the Code Enforcement Officer on this Parcel contain the following condition:

"No certificate of occupancy shall be issued for the building that is the subject of this building permit, regardless of whether construction is complete, until such time that the private highway affording access to such building has been suitably improved to the satisfaction of the town planning board in accordance with standards and specifications approved by the town board, as adequate in respect to the public health, safety and general welfare for the special circumstances of the private highway giving access."
