#### Public Presentation: Preliminary Reviews

a) Application 1094, Roy Sensenig, 1978 Sutton Rd, Penn Yan

Mr. Sensenig explained that his current shop was built in 2008 with the purpose of building custom interior wood furniture. His business has changed and he would like to stop building custom furniture and focus on distributing wood finishing supplies to local woodworking shops. He would like to build an entry room, porch, truck unloading dock and a bathroom that would total about 450sf.

Supplies are delivered by 18 wheelers. The driveway has already been widened so the trucks can pull in and turn around; they are unloaded with a fork lift. On average, there are 2 truck deliveries a week between the hours of 10am and 4pm from the 12 - 16 companies he distributes for. To date, there have been no big weather related problems with the roads when trucks are making their deliveries.

The current business is considered a low-impact wholesale business since the structure is less than 3000sf. If Mr. Sensenig wishes to expand in the future he will need to go before the Zoning Board to obtain a variance.

There will be a Public Hearing on July 13<sup>th</sup> prior to the Zoning Board making a decision on the Special Use Permit.
