Local Law No. 6 of the year 2019

A Local Law to Amend Regulations of the Code of the Town of Jerusalem Pertaining to Sewers and Wastewater Management

Section 1. Article IV (Use Regulations) of Chapter 131 (Sewers) of the Code of the Town of Jerusalem is hereby amended with the insertion of a new Section 131-20.1 to read as follows:

§ 131-20.1 Periodic pump outs.

Those connected to the public sewer system may make periodic pump outs which promote environmental sustainability, recycling, and facilitate the efficient functioning of the public sewerage system. The Owner shall maintain a Log, of any such pump outs giving the date, waste hauler, volume and destination or disposal site.

Section 2. Paragraph A. of Section 150-4 (Disposal of wastewater) of Chapter 150 (Sewers) of the Code of the Town of Jerusalem is hereby repealed and a new Paragraph A is hereby inserted in its place to read as follows:

A. Wastewater from any new construction shall be directly connected to the public wastewater disposal systems if available and accessible within 200 feet of the property line.

Section 3. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

Section 4. This local law shall take effect upon both the filing with the Secretary of State.
