Public Presentation:

a) Revised Site Plan review/discussion for Lyon/Smith Brewing at 2597 Assembly Ave., Jerusalem

Following sketch plan review of options for revision at the February meeting, Bruce Lyon present the revised site plan prepared by Bill Grove. The planning board noted concerns that the area for exterior consumption of beer be limited and fenced. The board also recommended that the berm be extended to include the corner of Route 54A and Assembly Ave. The recommendations were accepted. (Updated drawings provided to the Town by Bill Grove.)

The board reviewed SEQR Part 1 and recommended that question 8a be modified to recognize that there would be some modest, potential for increased traffic near the corner of 54A and Assembly Ave. The board then review SEQR Part 2 with No or Small impact on all items except Item 10 but mitigated by the site plan. A motion was made for a negative declaration by J. Wheeler and seconded by P. Zorovich. All were in favor.

A Motion was made to approve the site plan by J. Wheeler and seconded by G. Farrell. All voted in favor.

a) Nasberg-Nelson – Steep Slopes Application for Demo/Construction at 2329 West Lake Road, Penn Yan

Chuck Smith, Mary Scipioni presented the site plan to the board. The board recommended that greater detail be provided on the Lake side of the plan with more complete specifications and cross section for the terraces providing drainage protection for the Lake. The final review was to be delayed to the April meeting.
