### SUPERVISOR

- Town Court partially reopened.
- The June 2020 Seneca Watershed Intermunicipal (SWIO) June meeting minutes included a report on the Seneca-Keuka 9E Watershed Plan. Data being collecting will be validated in 2021 and a plan finalized in 2022.
- Clean Up Day is cancelled for 2020 due to COVID-19 and concerns to keep our employees safe.
- Councilor Jones will follow up with Lynn Simmons to obtain details on his request to have the Town install "Right To Farm" signs. Town Code Chapter 82. Right to Farm was adopted in 2013.
- Supervisor Sisson stated fiscal concerns moving forward related to staff working unauthorized additional hours. It has been determined that these hours are not pre-approved, nor is the reason documented per policy. Despite the Department Head being put on notice, this has continued. Resolution #81-14

specifically states the Zoning Assessing & Planning Account Clerk Typist hours worked are 1820. During the COVID-19 shut down, while staff were paid their full work-week, time cards included hours beyond regular scheduled hours. Supervisor Sisson stated for the record that the Zoning Assessing & Planning Account Clerk Typist work schedule is 35 hours/week with no extra hours authorized or deemed necessary.

- The possibility of staff working remotely again due to COVID-19 and the need for the Town to move to the digital age was discussed.
- Mandatory training for employees and Board members will be offered through Yates County Skill-Up again this year.

#### COMPREHENSIVE PLAN REVIEW SUBCOMMITTEE

Subcommittee Chair Cutler will schedule a meeting of the Comprehensive Plan Review Subcommittee this month.

Randy Rhoads was introduced to the Board as a new member on the Subcommittee.

Concern was noted that during the winter, the dumpsters are currently placed where plowed snow in the parking lot is piled. Supervisor Sisson will send a request to the Yates County Public Works Committee Chair to move the disposal site to the Yates County Highway Barn on Guyanoga Road during the winter months.

Yates County Legislator Doug Paddock presented their operations report:

- Commendation for *The Chronicle Express* editor, Gwen Chamberlain whose position was eliminated by the newspaper's publisher.
- Renewal of the occupancy tax.
- Four positions were filled.
- Implementing a County GIS based public access portal.
- No bond is needed to fund the County portion of the USDA ReConnect Program for the fiber optic build.
- Public hearing scheduled July 27 on a local law to change the full-time elected Treasurer to a part-time position and create a Director of Finance position subject to mandatory referendum.
- Adopted a local law to clarify the Worker's Compensation Law physical examination requirement.
- Current COVID-19 statistics were presented.

# Exhibit 1 Legal Protections And External Remedies

Sexual harassment is not only prohibited by Town of Jerusalem but is also prohibited by state, federal, and, where applicable, local law.

Aside from the internal process at Town of Jerusalem, employees may also choose to pursue legal remedies with the following governmental entities. While a private attorney is not required to file a complaint with a governmental agency, you may seek the legal advice of an attorney.

In addition to those outlined below, employees in certain industries may have additional legal protections.

# State Human Rights Law (HRL)

The Human Rights Law (HRL), codified as N.Y. Executive Law, art. 15, § 290 et seq., applies to all employers in New York State with regard to sexual harassment, and protects employees, paid or unpaid interns and non-employees, regardless of immigration status. A complaint alleging violation of the Human Rights Law may be filed either with the Division of Human Rights (DHR) or in New York State Supreme Court.

Complaints with DHR may be filed any time **within one year (three years beginning Aug. 12, 2020)** of the harassment. If an individual did not file at DHR, they can sue directly in state court under the HRL, **within three years** of the alleged sexual harassment. An individual may not file with DHR if they have already filed a HRL complaint in state court.

Complaining internally to Town of Jerusalem does not extend your time to file with DHR or in court. The one year or three years is counted from date of the most recent incident of harassment.

You do not need an attorney to file a complaint with DHR, and there is no cost to file with DHR.

DHR will investigate your complaint and determine whether there is probable cause to believe that sexual harassment has occurred. Probable cause cases are forwarded to a public hearing before an administrative law judge. If sexual harassment is found after a hearing, DHR has the power to award relief, which varies but may include requiring your employer to take action to stop the harassment, or redress the damage caused, including paying of monetary damages, attorney's fees and civil fines.
