Local Law No. 3 of the year 2022

A Local Law Amending Chapter 143 (Taxation) of the Code of the Town of Jerusalem to Increase the Limits for the Alternative Veterans' Exemption for Town Taxes

Be it enacted by the Town Board

Town of Jerusalem

as follows:

Section 1. Article 1 (Alternative Veterans Tax Exemption) of Chapter 143 (Taxation) of the Code of the Town of Jerusalem is hereby amended with the repeal of § 143-1 (Exemption increased) and § 143-2 (When effective) and the adoption of a new § 143-1 and § 143-2 to be inserted in their places to read as follows:

§ 143-1 Exemption increased

Pursuant to Real Property Tax Law Section 458-a (2) (d) (ii), the exemptions from real property taxes for veterans provided by paragraphs (a), (b) and (c) of subdivision 2 of Section 458-a are hereby changed to twenty-four thousand (\$24,000), sixteen thousand (\$16,000), and eighty thousand dollars (\$80,000), respectively.

§ 143-2 When effective

This Article shall take effect upon its filing with the Secretary of State, but, pursuant to Real Property Tax Law Section 458-a, the exemption shall not be available until the 2024 tax year (2023 assessment roll).

Section 2. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

Section 3. This local law shall take effect upon filing with the Secretary of State.
