- The Reapportionment/Redistricting proposal was adopted to achieve parity in legislative districts. There were no changes to Jerusalem districts.
- Municipalities will again receive millings from the County Highway Department.
- The public safety project is proceeding.
- Public Hearing is scheduled July 11 to renew the local law establishing the occupancy tax.
- Yates/Schuyler County Household Hazardous Waste Day is July 23.
- Early voting is June 18-26 and Primary Day is June 28.
- A fee is charged for the electric car charging station based on the length of time used.

TREE TOP CIDERY SPECIAL USE APPLICATION

Zoning Board member Jim Bird stated concerns with the Tree Top Cidery Special Use application, 8842 East Bluff Drive that was reviewed by the Planning Board on June 2nd. This parcel is one of many that are split zone properties as it is partially in the R1 and AGR zoning districts. He feels this could become controversial and precedent setting for the entire R1 district.
