PUBLIC HEARING - CDBG SEWER PLANNING GRANT APPLICATION With proof of notice having been duly published and posted, Supervisor Sisson opened the Public Hearing at 7:03 P.M., asking for comments on the Town's application for \$50,000 in New York State Community Development Block Grant (CDBG) Planning funds to conduct a Sewer System Improvements Study.

Michael O'Connell of Larson Design Group made a presentation on the CDBG Program (attached). If awarded the grant, our local match will be \$2,500. An updated sewer study is needed as the last one was done in 2014. The focus of the study will be outdated pumps, infiltration and inflow, and prioritizing possible extensions and future projects.

Bonnie Clawson, 510 Ritchey Blvd. questioned mandatory connection as she has a newer septic system. She is concerned with the cost of public sewer, but would consider connecting in the future.

Tim Cutler, 4620 Vine Road stated the 2016 proposed Sewer Ext. #4 study area included Ritchey Blvd., Branchport and West Bluff Drive areas. An income study was not done at that time, but may be needed.

Michael Monahan, 318 Ritchey Blvd. polled his neighbors to determine interest in sewer on Ritchey Blvd. and presented the list to the Board.

HIGHWAY SUPERINTENDENT

- Written Budget Highway report on file in the Office of the Town Clerk.
- The cross-over pipe was installed on Italy Friend Road. Next week will be West Bluff Drive, then Stever Hill.
- More barricades will be placed on the East Bluff Drive road failure site. Supervisor Sisson received a request to open seasonal roads because of this road being closed.

WATER/SEWER REPORT

-Councilor Lent reported the Keuka Park Water Rehab Phase 2 capital project pre-construction meeting was held July $6^{\rm th}$ and work began July $18^{\rm th}.$

We continue to work with LyonSmith Brewery on required sewer testing. Samples will now include PH and be taken consistently.
13 service calls resulted in replacing 7 grinder pumps on East Bluff Drive over the holiday weekend. A 2" meter in the 6" sewer line was a choke point that was bypassed. A plan to eliminate this 2" meter will be developed to create better sewer flow.

• The Water/Sewer Department needs some guidance to ensure our lines are winterized in the area of the West Lake Road, Penn Yan slope failure.

• Hydrant flushing is 25% complete. Pulteney drawing 600 gallons/minute through our system on Tuesday and Thursday for 6-8 hours/day complicates the flushing schedule.

• A hydrant near Jud's Nursery on 54a currently out-of-service will be repaired/replaced. We were not able to identify the cause.

• Councilors Purdy and Lent and Supervisor Sisson registered for a webinar today covering the inner workings of Fire Hydrant and Gate Valve systems; which allow for long-term reliability of water systems.

COUNCIL

- Councilor Purdy is gathering information to hold a joint meeting of the Town, Planning and Zoning Boards and County Legislators to discuss preserving the character of the Town. Roles of the various boards will be added to the next edition of the Jerusalem Journal.
- Clean-Up Day was successful. Supervisor Sisson extended a thank you to the Mennonite Community for helping out.

SUPERVISOR

- Jack Wheeler resigned from the Planning Board.
- Jim Bird resigned from the Zoning Board.
