It will not apply to those properties that have paid the lump sum payment for either water or sewer capital. Fee will be equal to the current capital charge for that district multiplied by the number of EDU's. They will also be charging an application fee in addition to the impact fee. Capital charges for water commence when building permit is issued or when water meter has been installed and inspected. Sewer charges commence when sewer connection is approved by KPSW personnel.

<sup>\*\*\*</sup>Water and Sewer permits are valid for 90 days. Permits may be renewed one time for a total of 180 days for no additional charge. After 180 days, the original permit will become void, and the applicant will need to re-apply for water and/or sewer connection permit and pay an additional application fee of \$350.00.
