Chairman Glenn Herbert asked Jim Crevelling to preside over the meeting since he was not present at the April meeting.

A motion was made by D.Simpson and seconded by M.Steppe to approve the April Zoning Board minutes as amended. Amendments to April Zoning Board minutes are as follows: Pg. 3 paragraph 4 poll of the board to add, M. Steppe-grant. Pg. 7 (regarding application #980) as part of the motion to approve this area variance to add condition #5 (regarding the garage) that the rear yard set back shall be no closer than 12 ft. 6in. from the roof overhang to the north rear yard property line and therefore the rear yard variance is 7 ft. 4 in.).

ZAP Secretary had attended a meeting at Keuka Lake State Park, as had Town Bd. member M.Parson, regarding the State Park's gathering of data and information regarding the Finger Lakes Cultural and Historical Museum's inclusion into the Keuka Lake State Park. The folks from the Finger Lakes Cultural & Historical Museum were also present and they, too, are still working on gathering data and information as to the exact location of where they might be placing their building. There have been no decisions made yet. There has been a lot of speculation, but much work is yet to be done before any final decisions are made. The SEQR process will be done, with the Office of Parks and Recreation as Lead Agency. There will be an opportunity for public input at several different stages of the SEQR process.

It was noted that the Sub-Committee working on the re-zoning of Rte 54A was to be meeting with the public in June.
