Old Business:

Java Gourmet- This application will be on the April agenda. Cutler stated he felt the most recent plans were a little better than the first set. The plans still have a scaling issue. Gridley questioned if the 54A overlay district had been looked at with regards to this application, like having the parking in the rear. Pritchard stated he has seen big tour busses turning around in their driveway, maybe suggesting a no bus sign or no turn around sign.

Rubin suggested maybe checking to see if someone from Keuka College would be interested.
- B) Keuka College- Cutler explained that Keuka College is interested in updating the Athletic Fields. They would like to replace the turf on the field and put in a running track. This may be coming to the Planning Board soon. There are some questions about the AG-Res zoning.

- C) Keuka Commons- There has been some discussion about the development of this project. They are really serious about moving this forward. Some of the recent comments that have been made are to keep the communication between the Town and the College open. The College would like to start sometime this spring. The Commons would be mostly retail, bookstore, drive thru coffee (possibly a Starbucks or Tim Horton's) and some of it could be commercial.
