WHEREAS, after proposed Local Law A of 2016 is amended, the General Municipal Law of the State of New York requires that certain actions having to do with zoning and planning be referred to the Yates County Planning Board for its recommendation; and

WHEREAS, the State Environmental Quality Review Act of the State of New York and SEQR Regulation 617.4 (b) (10) provides that "any Unlisted action, that exceeds 25 percent of any threshold in this section, occurring wholly or partially within or substantially contiguous to any publicly owned or operated parkland, recreation area or designated open space, including any site on the Register of National Natural Landmarks pursuant to 36 CFR part 62, 1994 (see section 617.17 of this Part) is a "Type I" action which requires the preparation of an Environmental Assessment Form;

NOW THEREFORE THE TOWN BOARD HEREBY DETERMINES and ORDERS as follows:

- 1. The Town Engineer is directed to prepare an Environmental Assessment Form regarding this local law when directed to do so by the Supervisor.
- 2. The Town Clerk is directed to forward the usual request to the Yates County Planning Board regarding the adoption of this local law as soon as all documents required by that Planning Board have been assembled.

DATA COLLECTOR & PART-TIME TYPIST FOR CEO

- Councilor Anderson reported there were 4 applicants for the Data Collector position; 3 professionals and 1 very qualified Jerusalem resident. An offer will be extended to the resident.
- Councilor Anderson suggested the Town combine the Data Collector position with the part-time Typist for Code Enforcement.
- Supervisor Killen will ask Town Clerk McMichael to place an ad for the part-time Typist for Code Enforcement as outlined in Resolution #170-15.

DISCUSSION - TAX CAP OVERRIDE LOCAL LAW:

There was a short discussion about adopting the Tax Cap Override Local Law. If the law is not adopted and an audit recognizes over expenditures in the budget, it triggers a penalty. Adopting the local law will negate the Tax Freeze Rebates our tax payers receive, but the rebate program may end next year.

A local law "Amending the Provisions of Chapter 143 of the Code of the Town of Jerusalem Relative to the Senior Citizens Tax Exemption"

SECTION 1. §143-6 of Chapter 143 of the Code of the Town of Jerusalem is hereby repealed and a new §143-6 is inserted in its place to read as follows:

§143-6. Eligibility Limits

In accordance with §467 of the Real Property Tax Law, real property owned by persons aged sixty-five years or older will be exempt from taxation to the extent shown below as determined by the owner or owners' corresponding annual income:

This increase shall be effective with the 2016 assessment roll

SECTION 2. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

SECTION 3. This local law shall take effect immediately upon filing with the Secretary of State.
