Egelston, thence northerly one and one half rods be the same more or less to the northerly line of said proposed highway, thence westerly following the northerly boundary of said proposed highway to the easterly line of the highway leading from Kinneys Corners to the end of Bluff Point, thence southerly along the said easterly boundary of said highway to the point of beginning.

Being the same premises conveyed by Nathan Egelston and Mary J. Egelston to the Town of Jerusalem by release

dated June 23, 1903 and recorded in the Yates County Clerk's Office in Liber 95 of deeds at page 534.

ALSO ALL THAT OTHER TRACT OR PARCEL OF LAND described as all the land and premises owned and occupied formerly by Benjamin J. Egelston included within the description of a proposed highway as contained in his application in writing to the Commissioner of Highways of the Town of Jerusalem on the first day of June 1903 to lay out a highway across premises formerly belonging to him and others, the course and location of which highway being described and set forth in his above-mentioned application.

Being the same premises conveyed by Benjamin J. Egelston and Polly Egelston to the Town of Jerusalem by deed dated June 13, 1903 and recorded in the Yates County Clerk's Office in Liber 95 of Deeds at page 533.

ALSO ALL THAT OTHER TRACT OR PARCEL OF LAND described as follows: commencing at the northwest corner of the premises formerly owned and occupied by Philip Loder and running thence in a general easterly direction along the northerly line of said premises to a point in the line of lands formerly of Benjamin Egleston, thence southerly along said Benjamin J. Egelston's (formerly) westerly line one and one half rods be the same more or less to the southerly line of said proposed highway, thence westerly following the said southerly boundary of said proposed highway to the easterly line of the highway leading from Kinneys Corners to the end of Bluff Point, thence northerly along the said easterly boundary of said highway to the place of beginning.

Being the same premises conveyed by Philip Loder and Eliza his wife to the Town of Jerusalem by deed dated June 23, 1903 and recorded in the Yates County Clerk's Office in Liber 95 of Deeds at page 528; and

WHEREAS, in accordance with §205 of the New York State Highway Law, the Town Board and Town Highway Superintendent have executed a Certificate declaring such unopened highway or highways to be abandoned, such Certificate having been filed or to be filed in the Jerusalem Town Clerk's Office; and

WHEREAS, the Town Board has identified Michael J. Benulis to be the current owner of the lands on which the Properties are situate; and

WHEREAS, Mr. Benulis, through his attorney, Donald Schneider, has asked the Town to execute and deliver to Mr. Benulis a quit claim deed conveying the Town's interest in the Properties to Mr. Benulis to provide Mr. Benulis with clear title that is unencumbered by any interest or rights of the Town to the Properties; and

WHEREAS, Mr. Benulis has offered to pay all of the recording fees to the Yates County Clerk to effectuate this deed transfer, to pay all costs associated with the drafting of such deed, and to pay the Town any expense it incurs in reviewing this matter, including the Town's attorney's fees, in consideration for the Town conveying any of its interest in the Properties.

NOW THEREFORE, BE IT RESOLVED, that the Town Board has determined that there is no present need for a Town highway in the location of the Properties and that, further, with the abandonment, the Town has no present right in the Properties to now open them as a Town highway or highways; and

BE IT FURTHER RESOLVED, that the Town Board hereby determines that, with such highways never having been opened and with the highways now being abandoned, there is no longer any value to the Town in the Properties; and

BE IT FURTHER RESOLVED, that, because Mr. Benulis is paying all drafting and recording fees as well as the Town's attorney's fees and other expenses involved in conveying the Properties and because the Town Board has determined there is no value in whatever interest the public records show the Town has in the Properties, the offer by Mr. Benulis represents fair and adequate consideration for the Town's interest in the Properties; and

BE IT FURTHER RESOLVED, that, because the Properties are not needed for any Town purpose and because Mr. Benulis has offered fair and adequate consideration for the Properties, the Town Board agrees to convey by quit claim deed whatever interest the Town has in the Properties to Mr. Benulis; and

BE IT FURTHER RESOLVED, that the Supervisor is hereby authorized and directed to execute a quit claim deed conveying the Properties from the Town to Michael J. Benulis; and

BE IT FURTHER RESOLVED, that upon Mr. Benulis paying the Town whatever amount the Town has incurred in attorney fees and other expenses reviewing this matter and in conveying the Town's interest in the Properties, the Supervisor is authorized and directed to deliver said deed to Mr. Benulis for recording; and

BE IT FURTHER RESOLVED, that this Resolution is subject to a permissive referendum and that the Town Clerk shall publish a notice thereof.

Town of Jerusalem Local Law No. B of the year 2019

A Local Law to Amend Chapter 145 (Vehicles and Traffic) of the Code of the Town of Jerusalem to Add New Parking Regulations

Be it enacted by the Town Board

Town of Jerusalem

as follows:

SECTION 1. Section 145-10 of Article II of Chapter 145 (Vehicles and Traffic) of the Code of the Town of Jerusalem is hereby amended with the insertion of new paragraphs C and D to read as follows:

- C. No person shall park a vehicle on any part of Central Avenue (Yates County Route 25) between the hours of 11:00 p.m. and 7:30 a.m. of the immediately following day. This parking prohibition shall apply every day throughout the year.
- D. No person shall park a vehicle on any part of Assembly Avenue (Yates County Route 25) between the hours of 11:00 p.m. and 7:30 a.m. of the immediately following day. This parking prohibition shall apply every day throughout the year.
- SECTION 2. Article II of Chapter 145 (Vehicles and Traffic) of the Code of the Town of Jerusalem is hereby amended with the insertion of a new Section 145-11 to read as follows:

§ 145-11 Time limit parking.

- <u>A.</u> Between the hours of 7:30 a.m. and 11:00 p.m., no person shall park a vehicle for longer than ten (10) minutes on the west side of Central Avenue (Yates County Route 25) from the south side of Chestnut Street to the north side of Assembly Avenue. This parking prohibition shall apply every day, except Sundays, throughout the year.
- B. Between the hours of 7:30 a.m. and 11:00 p.m., no person shall park a vehicle for longer than ten (10) minutes on the east side of Central Avenue (Yates County Route 25) from the south side of Chestnut Street, as extended, to the north side of Assembly Avenue, as extended. This parking prohibition shall apply every day, except Sundays, throughout the year.
- C. Between the hours of 7:30 a.m. and 11:00 p.m, no person shall park a vehicle for longer than ten (10) minutes on the north side of Assembly Avenue (Yates County Route 25) from the east side of Poplar Street to the west side of Central Avenue. This parking prohibition shall apply every day, except Sundays, throughout the year.
- SECTION 3. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence,

paragraph, section or part thereof directly involved in the controversy in which such judgment shall have been ordered.

SECTION 4. This local law shall take effect immediately upon filing with the Secretary of State.
