(a) Subdivision Application 03-2021 Steve McMichael, 4726 West Bluff Drive, Keuka Park, NY 14478

Steve McMichael – explained subdivision to planning board

Donna Gridley – questioned what looks like a private road

Steve McMichael – explained stating NYSEG needed that road for new poles that were put in

(b) Sketch Plan Discussion, Dan Lewis, Small Business (Finger Lakes Power Systems) 3333 Skyline Drive, Penn Yan, NY 14527

Tim Cutler – stated he plans to apply for Special Use Permit (Installing generators in the area)

Tim Cutler – he has an idea of what is needed for Site Plan but wants to review

Dan Lewis – Explained – currently in Keuka Business Park and operating from there. Shared what he would wants to do with board. Will have 2 full time office staff, 1 part time employee, and equipment will be stored in the building. Customers will be by appointment. Low impact warehouse was described.

Tim Cutler – discussed septic placement

Dan Lewis – reviewed location of building and has spoken to neighbors

Dan Lewis – will have some inventory and supply generators inside the building, he had an electric business prior to this new venture

Tim Cutler – shared what is needed for the Site Plan: Leach field, septic tank location, building location, single story, along with driveway and parking/lighting.

Dan Lewis – will have a horseshoe driveway with parking on the back side of the building, does not want trucks by the road.

Tim Cutler – explained that the Planning board and Zoning boards may have different questions. Tim asked about the driveway and explained that the town will need to know this.

Dan Lewis – will most likely be a gravel driveway

Tim Cutler – discussed signs

Dan Lewis asked if the Site plan needed to be stamped

Tim Cutler – Site plan and survey need to be stamped

Dan Lewis – discussed pole barn structures

Donna Gridley share a similar pole barn as a possible example to look at

Dan Lewis thanked the Planning board for taking the time to review

Tim Cutler – shared the Advisory committee will be meeting regarding grants

Comprehensive Planning – pushed back to Spring per Tim Cutler
